Restated Articles of Incorporation of

The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole

The Articles of Incorporation originally filed on March 20, 2003, are amended and restated as follows:

Article 1. Name.

1. The name of this benevolent, eleemosynary corporation sole is “*The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole*”.

2. For improved readability, *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* is sometimes referred to herein in abbreviated form as “*This Corporation Sole*”. In all cases, abbreviated or not, the name is shown in italics. Nothing else is shown in italics.

3. The name conforms to Nevada law which specifies at NRS 84.030(1) that the name of a Nevada corporation sole may consist of the title of the office of the person making and subscribing the articles, followed by the name of the church, followed by the words “and his successors, a corporation sole.” The “Servant” is the presiding officer of “The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels”, which is a church.

4. The masculine pronoun “his” has been used in the name because it is required by the statute. No gender discrimination is intended.

Article 2. Resident Agent.

1. The Resident Agent of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* is:

as evidenced by the Certificate of Acceptance of Appointment as Resident Agent executed by the same.

Article 3. Definitions.

1. The following definitions apply within these Articles of Incorporation:

- (a) Church. A “church” is an organization of Beings who have come together for spiritual purposes, where such organization may or may not be incorporated, and where such Beings may or may not be incarnated as a Sentient Human Beings.
- (b) Mother church. A “mother church” is a church which guides, instructs and governs one or more other churches, which are called its child churches.
- (c) Child church. A “child church” is a church which is guided, instructed and governed by another church, which is called its mother church.
- (d) Angel. An “angel” is any Being who is sincerely devoted to serving God on the basis of Love, Goodness, Truth, Peace, Joy, Caring and Generosity.
- (e) Human angel. A “human angel” is an angel who is incarnated in a physical human body on this planet Earth as a Sentient Human Being.
- (f) Etheric angel. An “etheric angel” is an angel who is not incarnated in a physical body.
- (g) Angelic realm. An “angelic realm” is a child church.
- (h) And/or. The term “and/or” means “or” but with emphasis on its logical inclusiveness.

Article 4. Mother - Child Church Relationship.

1. *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* is a child church, incorporated by these Articles of Incorporation.

2. “The Legacy of the Angels” is an unincorporated mother church, whose child churches are called “Angelic Realms” or “Angelic Realms of The Legacy of the Angels”.

3. The mother church of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* is The Legacy of the Angels. Therefore, *This Corporation Sole* is an Angelic Realm (i.e. a child church) of its unincorporated mother church, The Legacy of the Angels.

Article 5. The Mother Church.

1. The Legacy of the Angels, which is the mother church of *This Corporation Sole*, is an ancient, unincorporated spiritual movement based on Divine Vedic Knowledge, which is the Supreme Knowledge of the integration of life. This Supreme Knowledge has been enshrined, carried forward and upheld in its purity across great epochs of time by the Vedic Tradition.

2. As a church, The Legacy of the Angels, which is the mother church of *This Corporation Sole*, is an organization of angels—both etheric angels and human angels—each of whom is growing in this Supreme Knowledge.

3. The Legacy of the Angels, which is the mother church of *This Corporation Sole*, is governed by its etheric angels, and its Earthly activities are carried out by its human angels under the guidance and direction of its etheric angels.

4. The roots of The Legacy of the Angels, which is the mother church of *This Corporation Sole*, begin with the first custodian of the Supreme Knowledge, Lord Narayana, whose eternal incandescence is the embodiment of absolute Being. From him, the custodianship devolved upon Brahma, the Creator, who is born of the lotus rooted in absolute Being. The custodianship of this Knowledge was later held by Vasishtha, and then by Shakti, and then by Prarashara, and then by Veda-Vyasa. Veda-Vyasa compiled the Vedas and wrote the Upanishads and the Mahabharata, including the Bhagavad Gita, the great discourse of infinite wisdom given to Arjuna by Lord Krishna. Veda-Vyasa also wrote the eighteen Puranas and the Bhagavatam. The custodianship of this Knowledge was later held by Shukadeva and then by Gaudapadacharya, who was a powerful exponent of the essence of Vedic Wisdom, Vedanta, which is a direct means to the realization of Divine Unity in day to day life. The custodianship of this Knowledge was later held by Yogi Govinda, and then by Adi-Shankaracharya, the Master of Bhagavan and the first Shankaracharya, whose Vedic revelations constitute the Shrutis, the unchallengeable and irrefutable expressions of the Divine Truth, which were

distilled for application as the Smritis. Adi-Shankaracharya further compiled the Brahma Sutras to facilitate the wisdom of the Upanishads and bring the reality of this eternal Oneness of life to men and women of all times. Adi-Shankaracharya passed the custodianship on to his four disciples, Padma Pada, Hasta-Malaka, Vartika-Kara, and Trotaka. The custodianship of this Knowledge was held in the late 19th century and the first half of the 20th century by Swami Brahmananda Sarasvati Maharaj and continues to be carried on by the living Enlightened Masters of the Holy Tradition today.

5. The roots of The Legacy of the Angels, which is the mother church of *This Corporation Sole*, also encompass the revelation of Supreme Knowledge by (1) other Enlightened Masters, including, without limitation, Buddha, Christ Jesus, and Mohammed, (2) other human angels, and (3) etheric angels.

Article 6. Legal and Spiritual Authority.

1. *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* derives its existence from two distinct authorities—one legal and the other spiritual. The legal process of “incorporating” that which was previously unincorporated is analogous to the spiritual process of “incarnating” that which was previously non-incarnated.

(a) Legal Authority. The legal authority for *This Corporation Sole* is Nevada law. These Articles of Incorporation legally establish *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* as a Nevada corporation sole, under the legal authority of Chapter 84 of NRS. The Servant who occupies *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* shall be a human being who is legally bound by these Articles of Incorporation.

(b) Spiritual Authority. The spiritual authority for *This Corporation Sole* is its mother church, The Legacy of the Angels. “The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels”, which is the child church embodied by *This Corporation Sole*, has existed in non-incarnated form since ancient times, and it is now brought forth into earthly, incarnated form by instruction of the etheric angels of the mother church. These Articles of Incorporation spiritually establish *The*

Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole as an incarnated child church of its mother church, The Legacy of the Angels. The Servant who occupies *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* (1) shall be a human angel who is spiritually bound by these Articles of Incorporation, (2) shall receive his or her guidance and instructions with respect to *This Corporation Sole* from the etheric angels of The Legacy of the Angels, the mother church, and (3) shall follow such guidance and carry out such instructions under the auspices of *This Corporation Sole*.

2. Nothing in these Articles of Incorporation shall preclude the incorporation and incarnation of other child churches as corporations sole (under the laws of Nevada or any other jurisdiction) whose mother church is The Legacy of the Angels. Nothing in these Articles of Incorporation shall prohibit one human angel from occupying the presiding office of more than one such child church.

3. If the human angel who occupies the Office of the *Servant* also holds another title with respect to another entity, then, when he/she takes an action, the question of which entity (if any) is the object of the action (i.e. in which “capacity” he/she is acting; or which “hat” he/she is wearing when taking the action) shall be determined solely at his/her discretion. No action taken with respect to another entity shall have any bearing or effect upon on *This Corporation Sole*, unless such action is expressly intended by the Servant to also affect *This Corporation Sole*.

Article 7. Genesis.

1. “The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels,” which is the child church embodied by *This Corporation Sole*, has existed in unincorporated, non-incarnated form since ancient times. The creation of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* is an activity of God wherein this child church is incorporated and incarnated into an Earthly legal entity and church body. This creation occurs in a two-step process that is analogous to the creation of a human life. In step one, *This Corporation Sole* begins its existence as an unborn fetal body within the

womb of the mother church. In step two, *This Corporation Sole* is “born” from the womb of the mother church into its full-fledged existence.

2. This Article precisely defines: the act of God that creates the unborn fetal body of *This Corporation Sole*, the limited powers of *This Corporation Sole* while in its fetal form, and the act of God that gives birth to *This Corporation Sole* from the womb of the mother church. The broad powers of *This Corporation Sole* after it has been born from the womb of the mother church are described in other Article(s) of these Articles of Incorporation.

3. The act of God which shall create the unborn fetal body of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* within the womb of the mother church shall be God moving in, through and as a person, who works in a duly authorized capacity in the office of the Secretary of State of Nevada, and God causing this person to duly stamp and file these Articles of Incorporation as incorporating a Nevada Corporation Sole.

4. From the time when its unborn fetal body is created as a Nevada Corporation Sole until its birth (as defined herein below), *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* shall have only those minimal powers necessary to sustain its existence in compliance with Nevada law, and it shall have no other powers whatsoever.

5. The act of God which shall cause *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* to be born from the womb of the mother church shall be God moving in, through and as the dimensions of time and place, and God arriving at a particular time, which shall be precisely 10:54 am Pacific Daylight Time on May 2, 2003 (referred to hereinafter as the “birth date/time”), when *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* shall, in that moment, be born at Crystal Bay, Nevada (on the North shore of Lake Tahoe) from the womb of the mother church into its full-fledged, perpetual, benevolent, eleemosynary existence.

6. On the birth date/time, the complete powers of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* specified in other Article(s) of these Articles of Incorporation shall commence and shall continue in perpetuity.

7. This Article shall never be amended or repealed; however it may be assigned a different article number and/or article title in a restatement of these Articles of Incorporation.

Article 8. Appointment of Servant.

1. The etheric angels of The Legacy of the Angels, which is the mother church of *This Corporation Sole*, have appointed Mark Laurence Donald Emerson, a human angel, as Servant to take possession of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole*.

Article 9. Vacancy and Succession.

1. The duration of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* is perpetual, and the death, permanent incapacitation or resignation of the Servant shall not affect the duration, but shall instead result in a vacancy in the Office of the Servant which shall necessitate the appointment of a successor.

2. The successors in the Office of the Servant shall be appointed to fill each vacancy in a manner provided for in the private writings of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole*.

Article 10. Urgent Need on Planet Earth.

1. Unfortunately, as of the date of filing hereof, a “legacy of darkness” predominates on this planet Earth, wherein the systems, institutions, traditions and power structures of human civilization are based, to a significant extent, upon the negatives of greed, hate, fear, dishonesty, ignorance, violence and the concept of “command and control” of the naive masses by the privileged few. The result of this legacy of darkness is the large-scale suffering of humanity. Such suffering is entirely unnecessary. The need is extremely urgent right now for the drastic reduction and ultimate elimination of human suffering.

Article 11. Purpose.

1. The immediate purpose of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* is to carry out the benevolent, eleemosynary duties that are assigned to it by The Legacy of the Angels, which is its mother church, in furtherance of the mother church's ultimate purpose. Thus, as an instrumentality of its mother church, the ultimate purpose of *This Corporation Sole* is identical to that of its mother church.

2. Stated generally, the ultimate purpose of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* and, at the same time, the ultimate purpose of The Legacy of the Angels, which is its mother church, is to eliminate the suffering of humanity on planet Earth.

3. Stated specifically, the ultimate purpose of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* and, at the same time, the ultimate purpose of The Legacy of the Angels, which is its mother church, is:

- (a) to support and to effectuate, by any and all practicable, nonviolent, lawful, loving and Light-filled means, the transformation of the systems, institutions, traditions and power structures of human civilization from the existing legacy of darkness into a "Legacy of Light";
- (b) to maintain and to expand that Legacy of Light forever; and
- (c) to anchor Heaven and global celebration firmly onto this planet Earth for the great benefit of all the people currently living on this planet Earth as well as their posterity for time immemorial.

4. As transformed from the legacy of darkness into the Legacy of Light, the systems, institutions, traditions and power structures of human civilization shall be designed, created and maintained on the basis of Truth, Divine Law, Oneness of all in God, Enlightened Wisdom, unconditional Love, Compassion, loving Kindness, Joy, Happiness, Friendship, Beauty, unlimited Abundance, Liberty, individual Sovereignty, voluntary Righteousness, Harmony, sacred Resonance, Trust, Peace, nonviolence, clarity, openness, receptivity, acceptance, non-rejection, healing, holistic awareness, fun, the principle of simultaneously honoring diversity and unity, the principles of reincarnation and karma, the understanding that within every culprit lies a victim and that

the key to transforming any culprit is not to punish culprit but rather to heal the victim within the culprit, the great empowerment of the individual, the practice of divine mathematics including (without limitation) the sacred division of each relevant space into the highest possible number of orthogonal dimensions, the enlightened understanding of the creative process in its male, female and sexual aspects, and the prayer that once created, these systems, institutions, traditions and power structures are only a Blessing to human civilization.

5. *This Corporation Sole* is tasked by The Legacy of the Angels, which is its mother church, to embody, uphold, sustain, support and divinely protect the holy, surrendered service to our global civilization by the Servant and by certain individuals appointed by the Servant.

6. *This Corporation Sole* is organized exclusively for, and shall be operated exclusively for, religious, charitable, scientific, testing for public safety, literary, and/or educational purposes that are consistent with, and in support of, the elimination of human suffering on planet Earth.

7. The property of *This Corporation Sole* is irrevocably dedicated to eliminating the suffering of humanity and to anchoring Heaven and global celebration onto planet Earth. This paragraph shall never be amended or repealed.

Article 12. Membership.

1. Two distinct types of membership are defined herein:

(a) Membership in the mother church. Members of the mother church, which is The Legacy of the Angels, shall be called “Angels of The Legacy of the Angels”, or, in abbreviated form, “Angels” (capitalized).

(b) Membership in this child church. Members of the child church, which is *This Corporation Sole*, shall be called “Members of the Holy Realm of Surrendered Service to Global Civilization”, or, in abbreviated form, “Members of the Holy Realm”.

2. Membership of either type shall be non-exclusive, meaning that members may also belong to other spiritual organizations and/or faiths, including, without limitation, religions, churches, synagogues, temples, mosques, and ashrams.

3. Neither type of membership shall require any fee or any donation to be paid at any time whatsoever.

4. Angels of The Legacy of the Angels shall be human angels and shall include the Servant. There shall be one, and only one, requirement for membership in The Legacy of the Angels, which shall be to take the following angelic vow:

“I, _____, hereby declare that I am an angel who is sincerely devoted to serving God on the basis of Love, Goodness, Truth, Peace, Joy, Caring and Generosity.

“As an angel, I hereby join The Legacy of the Angels.

“As an Angel of The Legacy of the Angels, I hereby make [or re-affirm] my spiritual commitment to God to utilize to the utmost my angelic talents and gifts, as well as my time, energy and resources, in my own angelic way and as guided directly by God, to further the broad humanitarian purpose of The Legacy of the Angels to eliminate human suffering on planet Earth.”

5. Such angelic vow may be administered by any Angelic Realm of The Legacy of the Angels, including *This Corporation Sole*, thereby admitting Angels to membership in The Legacy of the Angels. However, such admission to membership confers neither (1) any legal right or legal relationship with such administering Angelic Realm, nor (2) any other type of membership.

6. Members of the Holy Realm of Surrendered Service to Global Civilization shall be Angels of The Legacy of the Angels and shall include the Servant. The private writings of *This Corporation Sole* shall provide for (1) the admission of new Members of the Holy Realm, (2) their sacred membership vows, (3) sacred work duties of such members, which shall be under the direction of the Servant, (4) ministration of sacerdotal functions by such members, (5) religious tenets and practices applicable to such members, and (6) the conduct of religious activities and religious worship by such members.

7. The Members of the Holy Realm of Surrendered Service to Global Civilization shall comprise a holy religious order. Acting as a religious order under the direction of the Servant, Members of the Holy Realm shall carry out the humanitarian work of *This Corporation Sole*.

Article 13. Angelic Missions.

1. The Legacy of the Angels, which is the unincorporated mother church of *This Corporation Sole*, includes, within its broad spiritual scope as a mother church, (1) its various child churches (called Angelic Realms, of which *This*

Corporation Sole is one), and (2) the spiritual missions of its Angels, which are called “Angelic Missions” or “Angelic Missions of The Legacy of the Angels”.

2. Any Angel of The Legacy of the Angels may create an Angelic Mission of The Legacy of the Angels, through which he/she exercises a spiritual commitment to advance the broad spiritual purpose of the mother church, to eliminate human suffering.

3. Each Angelic Mission shall have a name which shall be unique among all the Angelic Missions of The Legacy of the Angels.

4. Each Angelic Mission shall have a Missionary, who is an Angel of The Legacy of the Angels. The Angel that creates an Angelic Mission shall be its initial Missionary.

5. Each Angelic Mission shall have a statement of its humanitarian purpose, which shall be consistent with, and in support of, the ultimate purpose of the mother church to eliminate the suffering of humanity on planet Earth.

6. *This Corporation Sole* shall be a “Registrar of Angelic Missions”. Other Angelic Realms of The Legacy of the Angels may also be Registrars of Angelic Missions, and *This Corporation Sole* shall cooperate with such other Angelic Realms to coordinate the registering of Angelic Missions and the keeping of the church records thereof.

7. To create an Angelic Mission, an Angel of The Legacy of the Angels shall submit an application to a Registrar of Angelic Missions. Such application shall include the name and humanitarian purpose of the proposed Angelic Mission. Upon finding that an application meets the requirements stated herein, as well as any other church policies concerning Angelic Missions, the Angelic Mission shall be registered, and shall thereby be spiritually united into The Legacy of the Angels, which is the unincorporated mother church of *This Corporation Sole*.

8. The Missionary of an Angelic Mission may change the statement of its humanitarian purpose by application to, and approval by, a Registrar of Angelic Missions.

9. The Missionary of an Angelic Mission may, by notification to a Registrar of Angelic Missions, appoint another Angel of the Legacy of the Angels as successor Missionary, who shall become the Missionary upon the resignation or death of the existing Missionary.

10. An Angelic Mission may be any of the following: (1) an Angel acting as a sole missionary, (2) a missionary partnership of Angels, (3) a nonprofit corporation, (4) a nonprofit association, (5) a charitable trust, or (6) a

corporation sole. The Missionary of the Angelic Mission shall either (1) control the Angelic Mission or (2) be in a position of substantial influence over the management of the Angelic Mission.

11. An Angelic Mission shall not be any of the following (1) any entity that is set up for the profit-making purposes of its owners, including, without limitation, a for-profit corporation, a for-profit general partnership, a limited partnership, a limited liability partnership, a limited liability company, or (under common law) a joint stock company, (2) a business trust set up for the profit-making purposes of its trustee and/or beneficiary, (3) a trust whose beneficiary includes (directly or indirectly) any named human being or the descendants of any named human being, (4) an estate, (5) a political party or political campaign, or (6) any government entity, including, without limitation, a government, government subdivision, government agency or quasi-government entity.

Article 14. Sacred Industrial Projects.

1. Any industrial project undertaken and managed by *This Corporation Sole*, or by any other Angelic Realm, or by any group of Angelic Realms acting in concert, which group may include *This Corporation Sole*, shall be called a “Sacred Industrial Project of The Legacy of the Angels” or, in abbreviated form, a “Sacred Industrial Project”.

2. Sacred Industrial Projects shall be dedicated, in all of their aspects, to advancing the broad spiritual purpose of The Legacy of the Angels, which is the mother church of *This Corporation Sole*, to eliminate human suffering on planet Earth.

3. Sacred Industrial Projects shall be based upon enlightened technologies created by enlightened inventors and developers, whose motivations are spiritual rather than material and who, in the process of inventing or developing such technologies, contribute to eliminating human suffering on planet Earth.

4. Sacred Industrial Projects shall be financed by capital that is obtained by sacred means which, by the raising of such capital, contributes to eliminating human suffering on planet Earth.

5. Sacred Industrial Projects shall engage the industrial work services of human angels and other spiritually open people, who, by performing such work, receive blessings and contribute to eliminating human suffering on planet Earth.

6. Sacred Industrial Projects shall produce products and/or services, all of which shall, by their manifest nature and by the prayerful intentions behind their creation, bring spiritual blessings to each end-user. The process of anyone utilizing any such product and/or service shall contribute to eliminating human suffering on planet Earth.

7. Sacred Industrial Projects shall market their products and/or services by sacred means which, in the process of such marketing, contributes to eliminating human suffering on planet Earth.

8. Any facility of a Sacred Industrial Project (including, without limitation, any factory, office, warehouse, shop, school, meeting room, studio, yard, or field, whether a permanent or a temporary facility) shall be dedicated as a sacred facility, and shall be appointed and operated in a manner that spiritually uplifts the people who work at and visit the facility.

9. The customers and/or end users of the products and/or services of a Sacred Industrial Project shall be required, by any practicable means, to make the following promise prior to purchase and/or use:

“I promise to use _____ [name of product or service] only for good purposes that do not harm others.”

10. Subject to the sole discretion of the Angelic Realms controlling them, Sacred Industrial Projects shall not do any of the following:

- (a) Engage in, or intentionally motivate others to engage in, any activity for the purpose of profit or pecuniary gain.
- (b) Utilize any industrial process that harms the environment of planet Earth.
- (c) Produce any product or service that is potentially harmful to its intended users, when used as it is intended to be used.
- (d) Permit any of its products or services to be used by individuals, organizations or government entities that have demonstrated a pattern of inflicting harm on others and who can reasonably be expected to use such products or services for the purpose of harming others.

Article 15. Sacred Investments.

1. With respect to money, *This Corporation Sole* and The Legacy of the Angels, which is its mother church, embrace the following three spiritual tenets:

- (a) We, as loving individuals, are One with God, One with each other, and One with all things, including money. God is the Oneness and the ultimate Love. Money only becomes evil when it gets separated from Love. When money flows with Love and in honor of the Oneness, money becomes a sacred substance.
- (b) When a gift of financial support for a good cause is donated freely and without legal recourse, it will be magnified and returned to abundantly bless the donor, thereby empowering the donor to do greater good.
- (c) Gold has deep spiritual powers that transcend its physical and chemical properties. Gold is not merely a commodity. It is the sacred money supply that is provided by Mother Earth to flow with Love through the hands of the people of this world and offer them its blessings of prosperity.

2. “Donated-Capital Grant-Yielding Industry Financing” is a system of sacred investment for financing Sacred Industrial Projects on the basis of these three spiritual tenets.

3. “DCGYIF” shall be the acronym for Donated-Capital Grant-Yielding Industry Financing. DCGYIF shall be pronounced in three syllables, “DOC-GY-LIF”, as follows. In the first syllable, the “D” is pronounced as in “Donated”, the “O” as in “honest”, and the “C” as in “Capital”, and thus “DOC” is pronounced as in “doctor”. In the second syllable, which is the accented syllable, the “G” is pronounced as in “Grant” and the “Y” as in “Yielding”, and thus “GY” is pronounced like the “gi” in “yogi”. In the third syllable, the “L” is pronounced as in “Yielding”, the “I” as in “Industry” and the “F” as in “Financing”, and thus “LIF” is pronounced as in “lift”.

4. The purpose and goal of Donated-Capital Grant-Yielding Industry Financing (DCGYIF) shall be to create a financial resonance among Sacred Industrial Projects and Angelic Missions that collectively empowers them to eliminate the suffering of humanity and to firmly anchor Heaven and global celebration onto planet Earth for the great benefit of all living people and their posterity for time immemorial.

5. DCGYIF sacred investments shall be made only by Angels of The Legacy of the Angels. A DCGYIF sacred investment made by an Angel shall be a spiritual commitment to serve humanity, consisting of four parts:

- (a) The Angel vows to support in his or her consciousness the broad humanitarian work of The Legacy of the Angels, including is Sacred Industrial Projects. This support may be offered by

regular prayer and/or by other spiritual means, at the discretion of the Angel.

- (b) The Angel creates an Angelic Mission of The Legacy of the Angels, and vows to do his or her utmost as its Missionary to achieve the stated humanitarian purposes of the Angelic Mission, in a manner consistent with the broad humanitarian purpose of mother church to eliminate human suffering on planet Earth.
- (c) The Angel freely, unconditionally, and without creating any financial right or legal recourse, donates capital to an Angelic Realm of The Legacy of the Angels to finance a Sacred Industrial Project. The Angel designates an Angelic Mission in connection with the donation, which may be his or her own Angelic Mission. Upon receipt of the donation, the Angelic Realm, acting in its capacity as Registrar of Angelic Missions, “endears” some number of “hearts” to the designated Angelic Mission, and the hearts are labeled to identify the Sacred Industrial Project. The number of hearts endeared is based upon (1) the size of the donation, (2) the timing of the donation in relation to the maturity of the Sacred Industrial Project, and (3) whether the donation is made in gold. Additional capital donated to the same Sacred Industrial Project and designating the same Angelic Mission results in an accumulation of hearts, so labeled, that are endeared to the Angelic Mission. In the event that donations are made to other Sacred Industrial Projects designating the Angelic Mission, the hearts are separately labeled and separately accumulated.
- (d) When and if a Sacred Industrial Project matures to the point of producing a surplus of cash, any portion of any surplus may, at the loving discretion of the Angelic Realm controlling the funds, and under no obligation of contract to do so, be distributed in the form of “heart grants” to the Angelic Missions of The Legacy of the Angels. In the event of a heart grant distribution, the grant amounts paid to the Angelic Missions may, at the loving discretion of the Angelic Realm controlling the funds, and under no obligation of contract to do so, be in proportion to their endeared hearts labeled for the Sacred Industrial Project that produced the funds. When practicable, grant distributions may, at the loving discretion of the Angelic Realm controlling the funds, be made in gold. Upon receipt of such grant funds by any Angelic Mission for which the Angel is the Missionary, the Angel shall cause the funds to be utilized exclusively to further the

humanitarian purposes of the Angelic Mission, in a manner consistent with the broad humanitarian purpose of the mother church to eliminate human suffering on planet Earth.

6. Hearts shall be an internal point system within the mother church for the purpose of apportioning grants, and nothing more. Hearts shall be neither tangible property nor intangible property. Hearts shall not be “owned” by any Angelic Mission or by any other person or entity. Once endeared to an Angelic Mission, hearts shall never be transferred to any other Angelic Mission, person or entity. Hearts shall be non-transferable, and if the Angelic Mission to which they are endeared is terminated, the hearts shall cease to exist.

7. DCGYIF sacred investments shall neither be made, nor be construed to be made, for profit or pecuniary gain. The purpose of a DCGYIF sacred investment is entirely spiritual. DCGYIF and the system of sacred investment it defines comprise an integral part of the broad humanitarian plan of *This Corporation Sole* and The Legacy of the Angels, which is its mother church, to eliminate human suffering on planet Earth.

Article 16. Sacraments.

1. A “sacrament” is any activity that strengthens the mutually loving relationship between an individual soul and God. *This Corporation Sole* and The Legacy of the Angels, which is its mother church, acknowledge the existence of an infinite number of sacraments.

2. The following is a partial and non-exclusive list of sacraments officially recognized by *This Corporation Sole* and by its mother church:

- (a) Praying.
- (b) Meditating.
- (c) Chanting or singing in praise of God.
- (d) Celebrating God.
- (e) Attending spiritual retreats.
- (f) Spending a day or more in silence.
- (g) Honoring all the religions of the world.
- (h) Honoring all enlightened masters and saints, past present and future, including Krishna, Buddha, Jesus and Mohammed.
- (i) Sitting in the presence of a living enlightened master or saint.
- (j) Practicing seeing God in others.

- (k) Practicing the Presence of God in and as our Self.
- (l) Revealing God to others.
- (m) Doing all things in a sacred manner.
- (n) Loving others unconditionally.
- (o) Teaching Goodness.
- (p) Teaching Truth.
- (q) Teaching Liberty.
- (r) Teaching Justice.
- (s) Spreading Peace and Joy.
- (t) Marrying and being devoted to the enlightened happiness of our spouse.
- (u) Enabling souls to incarnate on planet Earth by being their parents.
- (v) Welcoming newborns to planet Earth.
- (w) Being in fellowship with family.
- (x) Teaching children (and adults) to live a spiritual life.
- (y) Protecting children (and adults) from evil and falsehood.
- (z) Being an “angel” by serving God on the basis of Love, Goodness, Truth, Peace, Joy, Caring and Generosity.
- (aa) Being in fellowship with other Angels.
- (bb) Inspiring others to behave angelically.
- (cc) Becoming an Angel of The Legacy of the Angels.
- (dd) Soliciting Angel memberships in The Legacy of the Angels.
- (ee) Admitting members into The Legacy of the Angels.
- (ff) Encouraging Angels to create Angelic Missions, and helping them to do so.
- (gg) Elevating the material to the sacred.
- (hh) Undertaking and managing a Sacred Industrial Project.
- (ii) Soliciting DCGYIF sacred investments from Angels.
- (jj) Making a DCGYIF sacred investment.
- (kk) Soliciting donations to support a Sacred Industrial Project.
- (ll) Donating in support of Sacred Industrial Project.

- (mm) Receiving donations in support of Sacred Industrial Project.
- (nn) Recruiting Angels to work on a Sacred Industrial Project.
- (oo) Working on a Sacred Industrial Project.
- (pp) Causing the products, services and marketing activities of a Sacred Industrial Project to be filled with the Light and Love of God, and thereby to be made sacred products, sacred services and sacred marketing activities .
- (qq) Soliciting, via sacred marketing activities, the utilization and purchase of the sacred products and sacred services of a Sacred Industrial Project.
- (rr) With a reverence for the sacredness of the products and services of a Sacred Industrial Project, to prayerfully utilize and/or prayerfully purchase such products and/or services.
- (ss) Disbursing grants to Angelic Missions.
- (tt) As the Angel Missionary of an Angelic Mission, receiving grant funds and utilizing them to carry out the humanitarian work of the Angelic Mission.
- (uu) Giving our blessing to others.
- (vv) Giving charity to those who are suffering.
- (ww) Healing those who are sick.
- (xx) Bringing peace to those who are stressed, fearful, angry or in emotional pain.
- (yy) Aiding the victims of a disaster.
- (zz) Caring for the dying and blessing them in their transition.
- (aaa) Memorializing the lives of those who have departed.
- (bbb) Expressing gratitude to God, especially in times of difficulty.
- (ccc) Dropping the ego, again and again.
- (ddd) Offering everything to God, knowing that God takes the bad stuff away from us but lets us keep, and magnifies, the good stuff.
- (eee) Bringing our will into alignment with God's Will.
- (fff) Surrendering to God.
- (ggg) Refusing to believe in that which darkens the world (i.e. "evil"), and instead seeing it as a sacred opportunity for us to serve God by helping to transform it into Light.

(hhh) Dedicating our life to the elimination of human suffering on planet Earth.

Article 17. Rights, Privileges and Powers.

1. Upon its birth from the womb of its mother church as defined herein, *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* shall have, in perpetuity, all the rights, privileges and powers necessary to perform or engage in any lawful activity, including without limitation, (a) the conducting of its affairs as a child church of The Legacy of the Angels, which is its mother church, (b) the protection of its privacy and property, and (c) the protection of the liberty of the Servant and any other Sentient Human Beings associated with the Servant. There shall be no limitation in such rights, privileges and powers contained in or implied by these Articles of Incorporation except for those explicitly stated herein.

2. All such rights, privileges and powers of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* may be exercised in any form, through any transactional entity, and in any jurisdiction throughout planet Earth, at the sole and absolute discretion of the Servant, consistent with his/her sincerely held spiritual beliefs and consistent with guidance received directly by him/her from the etheric angels of The Legacy of the Angels, which is the mother church of *This Corporation Sole*. *This Corporation Sole* shall exercise such rights, privileges and powers by order of the Servant, which order may be expressed orally, or in writing, or both.

3. The rights, privileges and powers of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* shall include the following, limited only by the prohibitions explicitly stated in these Articles of Incorporation:

- (a) Conducting Affairs. *This Corporation Sole* may conduct its affairs and activities, locate its physical offices, and exercise its rights, privileges and powers in any jurisdiction anywhere on planet Earth, in the same manner and to the same extent as the most privileged natural person or legal entity does such things.
- (b) Contracts. *This Corporation Sole* may contract with other parties in the same manner and to the same extent as the most privileged natural person or legal entity contracts with other parties.

(c) Property and Money. *This Corporation Sole* may own, possess and hold property and money of any kind whatsoever, including, without limitation, real property, personal property, intellectual property, tangible property, intangible property, mixed property, securities, stocks, bonds, mutual funds, commodities, gold, silver and other precious metals, gems, partnership interests, membership interests, physical currency of any bank or government, and account balances measured in the currency of any bank or government or measured in any other thing. Such property and money may be located in any jurisdiction, country, state, province, county or location in the world or in any abstract or etheric domain. Such property and money is owned by *This Corporation Sole* and is not owned by the human being holding the Office of Servant. *This Corporation Sole* may acquire such property and money in any lawful manner, including, without limitation, by purchase, by exchange, by assignment, by transfer, by receipt of alms, gift, grant, donation, devise or bequest, or by lawful creation of the property by its activities. *This Corporation Sole* may utilize such property and money in any way that the most privileged owner of any property and money may utilize it, including, without limitation, occupying it, maintaining it, operating it, modifying it, spending it, lending, renting or licensing it to another party or to other parties, and binding it by means of mortgage or lien to secure any contract, but excluding any uses that would involve actions that are explicitly prohibited herein. *This Corporation Sole* may dispose of such property and money in any lawful manner, including, without limitation, by sale, by exchange, by assignment, by transfer, by expenditure, by investment, by giving as alms, gift, grant, donation, devise or bequest, or by lawful destruction, but excluding any means of disposal that would involve actions that are explicitly prohibited herein.

(d) Borrowing and Lending: *This Corporation Sole* may borrow property and/or money, with or without interest, with or without collateral. *This Corporation Sole* may lend property and/or money, with or without interest, with or without collateral.

(e) Accounts. *This Corporation Sole* may establish accounts in any bank or financial institution in any jurisdiction in the world, and it may engage in the activities to which the most privileged account holders are lawfully entitled, including, without limitation,

making deposits and withdrawals, borrowing funds, buying and selling investments, trading activity of any kind, earning interest, paying interest, and earning dividends.

- (f) Participation in Other Entities. *This Corporation Sole* may be the creator (grantor, settlor or trustor), trustee or beneficiary of any lawful trust. *This Corporation Sole* may be a shareholder in any corporation, joint venture or joint stock company. *This Corporation Sole* may be a general partner or limited partner in any partnership or limited partnership. *This Corporation Sole* may be a member or manager in any limited liability company. *This Corporation Sole* may be a member or associate in any society, church, association, foundation or non-profit corporation. *This Corporation Sole* may be an affiliate of any entity. *This Corporation Sole* may exercise any voting rights or other rights it may have as a trustee, shareholder, partner, member, manager, associate or affiliate of any entity.
- (g) Delegation. *This Corporation Sole* may delegate any of its powers to any person, office or entity at any time, for any period, in any lawful manner, upon any lawful terms, which terms may or may not include remuneration or honorarium. *This Corporation Sole* may create offices that are subordinate to the Servant, appoint human angels to such offices, and delegate any of its powers to such subordinate officers.
- (h) Property or Money Held by Nominee or Trust. *This Corporation Sole* may cause any of its property or money to be held, either by title or physical possession or both, by a nominee or trustee under any lawful terms.
- (i) Registration. *This Corporation Sole* may procure and maintain single or multiple registrations of itself in any jurisdiction, country, state, province, county or location in the world, and it may renew or rescind such registration(s) at any time, for any reason.
- (j) Payment. *This Corporation Sole* may pay expenses and honorariums for any service provided, with such payment being made from its property or money or the increases thereon or both.
- (k) Attorneys. *This Corporation Sole* may appoint attorneys in fact.
- (l) Disputes. *This Corporation Sole* shall endeavor to the greatest extent possible to resolve disputes in the Light by means of love, generosity, open communication, prayer, healing, patience and

other peaceful, nonviolent means. In the event that disputes cannot be resolved by peaceful means, *This Corporation Sole* may bring any action, pleading or lawsuit in any court, administrative tribunal or arbitration venue, within any jurisdiction in the world. In the event of any action, pleading or lawsuit being brought against it, *This Corporation Sole* may plead and defend itself against such action to the fullest extent possible in any court, administrative tribunal or arbitration venue, within any jurisdiction in the world.

- (m) Seal. *This Corporation Sole* may adopt and use a common seal by which deeds and acts of *This Corporation Sole* may be authenticated.
- (n) Members of Mother Church. *This Corporation Sole* may admit Angels to The Legacy of the Angels, as provided in another Article herein.
- (o) Members of Child Church. *This Corporation Sole* may admit Members of the Holy Realm of Surrendered Service to Global Civilization, and direct their activities as such members, as provided in another Article herein.
- (p) Solicitation of Memberships. *This Corporation Sole* may solicit for the purpose of recruiting memberships.
- (q) Angelic Missions. *This Corporation Sole* shall have the powers of a Registrar of Angelic Missions, as provided in other Articles herein.
- (r) Sacred Industrial Projects. *This Corporation Sole* may undertake and manage any Sacred Industrial Project, either on its own, or concert with other Angelic Realms of The Legacy of the Angels, as provided in other Articles herein.
- (s) Solicitation of Donations. *This Corporation Sole* may solicit donations from the Angels of The Legacy of the Angels. Donations may be solicited to fund any Sacred Industrial Project. Such donations may be used either directly by *This Corporation Sole*, or may be transferred to other Angelic Realm(s) of The Legacy of the Angels, provided such transfers are consistent with the purpose for which the donations were solicited. Such solicitations shall be lawful, and shall be void in any jurisdiction where prohibited by law.

- (t) Grants to Angelic Missions. Consistent with subparagraph (j) hereof, *This Corporation Sole* may pay grants to Angelic Missions of the Legacy of the Angels, which grants shall be stipulated to be used exclusively by such Angelic Missions to further its broad purpose to eliminate the suffering of humanity. Notwithstanding the funds for such grants arising, during any particular accounting period, from an excess of revenues over expenses in one or more spiritual activities of *This Corporation Sole*, such grants shall be treated as expenses of *This Corporation Sole* that are paid for services by such Angelic Missions, which services further of its broad purpose to eliminate the suffering of humanity.
- (u) Ecclesiastical Law. *This Corporation Sole* may establish its own system of ecclesiastical law, consistent with these Articles of Incorporation, to embody its spiritual tenets and sacraments, to manage its affairs, and to further its broad humanitarian purpose to eliminate human suffering.
- (v) Amendment. *This Corporation Sole* may amend these Articles of Incorporation as specifically provided by another Article herein.

Article 18. Prohibited Activities.

1. *This Corporation Sole* is prohibited from permitting any part of its net earnings to inure to the benefit of any private shareholder or natural person.

2. *This Corporation Sole* is prohibited from engaging (to any substantial extent) in any activity other than the furtherance of religious, charitable, scientific, testing for public safety, literary, and/or educational purposes.

3. *This Corporation Sole* is prohibited from engaging in any “trade or business” or “commercial activity” whose purpose is profit or pecuniary gain. However, *This Corporation Sole* is not prohibited from engaging in activities whose purposes are spiritual and/or humanitarian and that generate, during any particular accounting period, revenues that exceed expenses.

4. *This Corporation Sole* is prohibited from attempting (to any substantial extent) to influence any legislation or any political campaign by (1) contacting or urging the public to contact members of a legislative body for the purpose of proposing, supporting, or opposing legislation, (2) advocating the adoption or rejection of legislation, or (3) participating or intervening, directly or indirectly, in any political campaign on behalf of or in opposition to any candidate for public office. However, *This Corporation Sole* is not prohibited from advocating social or civic changes or presenting opinions on controversial issues with the intention of molding public opinion or creating public

sentiment to an acceptance of its views, consistent with the purpose stated herein. Nothing in this paragraph shall prohibit The Legacy of the Angels, which is an unincorporated church, or any Angel of The Legacy of the Angels, from engaging in political activities, provided such activities are not in any way funded by, or explicitly associated with, *This Corporation Sole*.

Furthermore, nothing in this paragraph shall prohibit any human angel who is a Member of the Holy Realm, or the human angel who occupies the Office of the Servant, from taking political action in some capacity other than as a Member of the Holy Realm, or as the Servant, and which action is neither the action of, nor has any legal or financial connection with, *This Corporation Sole*.

5. *This Corporation Sole* is prohibited from: (1) representing that hearts are “owned” by anyone or by any entity, including any Angelic Mission, (2) representing that hearts can be “bought” or “sold” or “liquidated”, or (3) transferring, or permitting to be transferred, any hearts which are endeared to one Angelic Mission to any other Angelic Mission or entity.

6. *This Corporation Sole* is prohibited from issuing or otherwise creating any “security” (such as a stock, bond, option, or investment contract) that would, in the opinion and sole discretion of the Servant, be subject to regulation by securities laws.

Article 19. Inspection of Records.

1. Except for these Articles of Incorporation which are a matter of public record, all other documents, books, records, accounts, and other information related to the internal affairs of *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* are private and shall not be disclosed to any third party unless the Servant deems such disclosure to further the purposes of *This Corporation Sole*. Inspection of such documents may be denied to any person, entity, officer, agent or court, public or private, governmental or non-governmental.

Article 20. Liability.

1. The Sentient Human Being holding the Office of the Servant shall not be personally responsible for any liabilities of *This Corporation Sole*, and *This Corporation Sole* shall not be responsible as an entity for any personal liabilities of the Sentient Human Being holding the Office of the Servant. Each succeeding Sentient Human Being holding the Office of the Servant shall

not be personally responsible for any liabilities, acts or failures to act of any previous Sentient Human Being holding the Office of the Servant.

Article 21. Amendment.

1. These Articles of Incorporation may be amended by lawful, written notice to the Nevada Secretary of State, marked and sealed by the Servant, provided that no amendment alters or removes any provision that is herein explicitly prohibited from being amended or repealed. However, the numbering of articles, paragraphs and subparagraphs within these Articles of Incorporation, and any numbered references thereto within these Articles of Incorporation, may be changed within, and with respect to, such unalterable provisions, provided such renumbering has no effect on the meaning of any unalterable provision. This paragraph shall never be amended or repealed.

2. Any such written notice of amendment made to the Nevada Secretary of State may be accompanied by a restatement of these Articles of Incorporation, as fully amended.


Article 22. Dissolution.

1. In the event that *The Office of the Servant of The Holy Realm of Surrendered Service to Global Civilization, an Angelic Realm of The Legacy of the Angels, and His Successors, a Corporation Sole* is dissolved in accordance with Nevada law, its assets remaining after provision for the payment of all its liabilities shall be distributed exclusively to nonprofit churches, missions and/or spiritual organizations whose primary purposes are substantially consistent with the purposes of *This Corporation Sole* to reduce human suffering and no part of whose net earnings inure to the benefit of any private shareholder or any natural person.
